<ul> <li>15 – <u>ELECTION OF COUNCIL</u> <ul> <li>(1) At least six weeks before the Annual Meeting of each year the returning officer shall forward by post to each member and Life Member of the Association a nomination form for each position of the Council with a notification thereon or therewith of the opening and closing dates and time of such nominations. The roll of voters for the election shall close 7 days before the date on which nominations open. The ballot for election of members of the Council of Management for the ensuing year shall be declared and these members shall be installed in office; provided, however, that this installation shall be the last item of business.	<b>25</b> - <b>ANNUAL MEETING</b> An Annual Meeting of members shall take place on a date determined by the Council of Management and that date shall be not later than 15 months after the Annual Meeting held in the preceding year.
